This document describes the billing details of Private Link.

Overview

The service cost of an endpoint consists of two parts: Endpoint instance fee and endpoint traffic fee.

Billing description

Item	Mode	Billing cycle	Unit price
Endpoint instance	Pay-as-you-go	Pay per hour	0.01 USD/instance/hour
Endpoint traffic	Pay-as-you-go	Pay per hour	0.01 USD/GB

Notes

Billing starts when the endpoint is associated. The minimum billable unit is one hour.

The traffic volume includes both the outbound and inbound traffic.

The pricing applies to all Tencent Cloud regions.

Billing example

Assume that you have an endpoint instance in VPC A, which is used to access the services deployed in VPC B. During 07:00:00 - 07:59:59, 21.68 GB of traffic is generated. The fees incurred during this period are calculated as follows:

Endpoint instance fee = 0.01 USD/instance x 1 instance x 1 hour = 0.01 USD

Endpoint traffic fee = 0.01 USD/GB x 21.68 GB = 0.2168 USD

Total fees = Endpoint instance fee + Endpoint traffic fee = 0.01 USD + 0.2168 USD = 0.2268 USD

Note:

For customers of Tencent Cloud partners, please refer to the overdue payment policies in your contract with the Tencent Cloud partner.

Tencent Cloud offers a grace period of 2 hours when the VPC endpoint expires. See below for details:

Billable item	Overdue period $<$ 2 hours	2 hours ≤ Overdue period < 2 hours + 24 hours	Overdue period \geq 2 hours + 24 hours
VPC endpoint	Service and billing continue	Service suspended, and billing stopped	VPC endpoint released
Endpoint traffic			Endpoint instance released, and billing stopped

Details policies:

When your account balance becomes 0, the VPC endpoint is still available for 2 hours, and the billing continues.

If the overdue payment is not cleared within 2 hours, the endpoint instance is automatically suspended, and the billing is stopped.

After the VPC endpoint is suspended, it remains in the status for 24 hours, during which you can make the overdue payment to recover it.

After the 24-hour period mentioned above, the VPC endpoint is released immediately and **cannot be recovered**. Upon releasing of the VPC endpoint, the Tencent Cloud account creator and all the collaborators are notified via emails and SMS messages.
